FREE – no minimum age limit

MASTERS + 40 YEARS

SUPER MASTERS + 50 YEARS

7x7 – no minimum age limit

Women 5X5 – no minimum age limit

REGULATION:



TEAM REGISTRATION:

The tournament is exclusively aimed at holders of a degree or Bachelor's degree in Law, regardless of their profession (Lawyers, Magistrates, Notaries, etc.), without prejudice to the regime of exceptions provided for in article six of the Competitive Regulation.

Each team must have:

Football 11x11: 15 to 24 players

Football 7x7: 8 to 16 players

5X5 Women: 7 to 12 players



TEAM FORMATION



Free - Lawyers with no minimum age limit

Masters – Lawyers over 40 years old (born before 12/31/1985), with the team being able to register 5 members born before 12/31/1990.

Super Masters - Lawyers over 50 years old (born before 12/31/1975), with the team being able to register 5 members born before 12/31/1980.

7x7 Football - Lawyers with no minimum age limit.

5X5 Women - Lawyers with no minimum age limit.

- **QUALIFICATION OF PLAYERS**

- **Team formation**

- Each team must be made up of lawyers, holders of a degree or a Bachelor's degree in Law, regardless of their profession.
- Each team can enter 3 elements that do not have a degree in Law, with the exception of the 7 x 7 competition that can only enter two elements and the 5 x 5 competition in which only 1 member can be registered.
- The admission of these exceptions will have to be submitted to the organization for approval, up to 30 days before the start of the competition, and they must comply with article 6 of the regulation.
- The participation, as an exception, of active professional soccer players will not be admitted.
- In each step, exceptions will have to respect the age limits defined for the same.
- All conditions specified above will be appreciated by the Organization.
- If a team participates in more than one category, the participation of 3 "joker" players is allowed, who can play games in any of the categories in which that team registers.
- In order for the use of these "joker" players to be allowed, the respective teams to which they belong must have a minimum number of 14 players (8 players in the case of the 7x7 tournament), not counting those.
- The "jokers" must necessarily have a Degree or Bachelor's Degree in Law and cannot constitute an exception in terms of the age defined for each step, as provided for in article 7 of the Competitive Regulation.





AWARDS

Prizes will be awarded in all tournaments:

- Champions, runners-up and 3rd place: cups and medals;
- All other teams will receive a cup with their classification;
- Prizes will also be awarded in each category to the best player, best scorer and best goalkeeper.
